Editors Ancestor Spotlight:

My Great Great Grandfather, was Private John Sharman. He was from Hamburg, Germany originally. On June 6, 1861, the day after his twenty second birthday, John enlisted in Co. E 3rd MO Vol. Infantry (3 month volunteers). In July of that year, he along with several comrades were transferred to Battery A of Maj. Franz Backoff's Artillery Battalion. This was done to replace several men who had come to the end of their enlistments. With this unit, John fought at Dug Springs, MO on Aug 2,1861 and at the Battle of Wilson's Creek, MO on Aug 10, 1861. At Wilson's Creek, he was shot three times. Once in each hand and once in the right side. After recovering from his wounds, he reenlisted in Capt. Martin Welfly's Independent Battery. This unit became Battery B of the 1st Regt. MO Vol. Lt. Artillery. With this unit, John fought at the Battle of Pea Ridge, the Siege of Vicksburg and several skirmishes in Louisiana. His unit also did occupation duty in Brownsville, Texas. On Sept. 30, 1864, John Sharman was discharged, having completed his three year enlistment. He passed away on April 26, 1904, in St. Louis, Missouri from kidney disease.

My Brothers All;

As we celebrate another 4th of July, in this year of our Lord 2011, I took the time to look backward in time ... back to my great-great grandfather, Christopher 'Kit' Hardesty, Sergeant in Company K, 6th Regiment of the Illinois Cavalry. He was quite a man, providing his own horse, saddle, and guns. He was part of the famous Griersons' Raid from LaGrange, Tennessee down through the heart of Mississippi in April 1863.

My family has a proud history of service in the military ... my father during the Second World War served in the South Pacific, I served in Korea in 1952-1953, and Vietnam in 1966-1967. My brother served in the Navy during the Vietnam war, and today, one grandson served with the 2nd Infantry, U.S. Army at Arlington National cemetery, another grandson served in Iraq and is currently assigned to Bagram Air Field in Afghanistan. My granddaughter served in the U.S. Navy and is now settled in as an old married lady living in Utah.

I hope you took time during this past holiday to reflect on your own family ... your own service time, if you served, and take time each day to pray for the safety of our military personnel that are deployed around the world. We took on the responsibility of being somewhat the worlds' police ... we have troops on the ground at the 38th parallel in Korea and have been entrenched there since the Truce was signed in 1953 ... a fact most Americans don't even recognize ... we never won that war, but only fought to a stand-still in June of 1953.

Our fighting in Iraq will come to an end this December, barring any unforeseen circumstances, and we begin the draw-down of troops in Afghanistan this year, and hopefully withdraw totally by the end of 2012. It would be a wonderful experience to see peace in our lifetime, and that's certainly something worthwhile praying for.



150 YEARS POST CIVIL WAR: Reflections of 30 years ago on this historic day

Had a restless sleep...woke up and making my way in the dark I went into the family room of my residence here in Palm Bay, Florida. As I felt my way through the room I noted the time from the LED display on the Cable TV box, like a beacon in the darkness it read 5:53AM...I walked into the kitchen to start the coffee brewing, doing my morning ritual as I get ready to go to work at a company called Harris Corp.

Suddenly the sound of a loud explosion shook my home. I heard the dog growl; I walked back into the family room to calm her. As I sat there petting the dog I thought about what might make such a noise...the space shuttle popped into my head. I turned on the TV and saw immediately a view of the runway from a camera mounted on the Space Shuttle. The view now shifted to a camera on the ground taking a shot of the Bird gliding over the runway. It was still dark and the images were shadows of gray, outlining that majestic man made Bird, the Space Shuttle ATLANTIS. My thoughts reflected back to the first Shuttle, because I knew this would be the last time a Space Shuttle would go on a mission.

At the time it was 1981, I was working at a company named Fairchild in Commack, New York. The company was named after Sherman Fairchild a captain of industry from the early 20th Century.

The director of Engineering called the Engineering group into the Proto-Type Lab where a television mounted into an equipment rack was rolled into the room and hastily hooked up to an antenna. We didn't have High Definition then and TV was Broadcasted on VHF Radio Waves. All of us in the Engineering Dept. stood there in awe as the first Space Shuttle COLUMBIA landed at Edwards Air Force Base in California. The tires hit the ground, trails of

smoke formed in swirls behind the Shuttle. Suddenly the room bust into a round of applause and cheers. We all felt very proud to be Americans, I was 27 years old at the time.

Thirty years later it's July 21st, 2011 and I'm now 57 years as the National Space Shuttle Program is about to have its final conclusion. I am alone standing in the family room with only the light of my flat screen High Definition TV illuminating the darkness. A tear rolls down my cheek as I reflected on the fate of the COLUMBIA. I watched as the tires of the Space Shuttle ATLANTIS touched down in Kennedy Space Center, Merritt Island, Florida. On camera the swirls of smoke could not be seen in the darkness. I was struck by the silence, no applause, my mood was sad and quite the opposite from that first time. Yet, I'm still proud to be an American. We the *PEOPLE* have been pioneers for a very long time, and I'm sure we'll continue in that spirit.
